  - A. Approval of this resolution will establish a mutual agreement with the City of South Milwaukee to outline the maintenance responsibilities pertaining to the Oak Creek watercourse in the form of a Memorandum of Understanding (MOU). The County and the City of South Milwaukee have an existing agreement to jointly maintain and operate the watercourse, so the purpose of the newly proposed MOU is to clarify the specific portions of the watercourse that each party is responsible for maintaining. The City of South Milwaukee has already voted in favor of this MOU at the January 2015 meeting of the Common Council.
  - B. There are no direct costs associated with this proposed MOU as only existing staff time is required. The County already jointly maintains and operates the watercourse with the City of South Milwaukee.
  - C. The County's maintenance responsibilities for the watercourse are already included within the Parks department's operations. Therefore, this MOU will have no additional budgetary impact for 2015 or subsequent years.
  - D. None.


