13 14 15 16 17 18	WHEREAS, the Department of Homeland Security (DHS) Transportation Security Administration (TSA) National Explosives Detection Canine Team Program (NEDCTP) has authorized funding for four TSA-certified explosives detection canine teams at \$50,500 per team; and
19 20 21 22 23	WHEREAS, DHS-TSA and the Sheriff agree to maintain assigned TSA canine teams that will be available to work within the transportation systems under the jurisdiction of the Sheriff, 24 hours a day, seven days a week, with the intent to provide maximum coverage during peak operating hours; and
24 25 26	WHEREAS, the total five-year estimated cost of TSA's share for the performance of this Agreement is \$1,010,000 and TSA's share is calculated utilizing the current number of authorized teams (four) at \$50,500 per team; and
27 28 29	WHEREAS, only funding for the base year of performance is provided at the time of the Other Transaction Agreement (OTA) award; and
30 31 32	WHEREAS, funding for years two through five will be provided via OTA modification on an annual basis; and
 33 34 35 36 37 	WHEREAS, the Sheriff agrees to maintain the ability to promptly respond to threats at support facilities within the Sheriff's Transportation Operating System (TOS) which affect public safety or transportation operations; and
38 39 40 41	WHEREAS, the Sheriff agrees that TSA canine teams will conduct frequent canine activities within view of the public, thereby providing a noticeable visible deterrent towards terrorist threats and other criminal activity; and
41 42 43 44 45	WHEREAS, the Sheriff agrees that the TSA-certified canine teams will be utilized at least 80% of their time in the Sheriff's TOS (General Mitchell International Airport); and
