13	WHEREAS, Wisconsin Statutes Section 59.52(31) requires that any contract with a
14	value or aggregate value of more than \$300,000 may only take effect if it is approved by a
15	vote of the County Board of Supervisors; and

17	WHEREAS, the Milwaukee County Zoo solicited proposals for beverage products,
18	which included dispensing equipment and annual financial support in return for beverage
19	exclusivity rights; and
20	
21	WHEREAS, in 2013, the Zoo spent \$233,211 on beverage products and generated
22	over \$836,000 in revenues just from those products; and
23	
24	WHEREAS, there are sufficient expenditures and revenues in the 2014 Adopted
25	Budget for beverage purchases and sales; and
26	W/UEDEAS, two wondows submitted proposals and the Dettling Crown, U.C./ Densi
27	WHEREAS, two vendors submitted proposals and the Bottling Group, LLC / Pepsi
28	Beverages Company proposal was chosen; and
29 20	W/UEPEAS, the Committee on Parks, Energy, and Environment at its meeting of
30 31	WHEREAS, the Committee on Parks, Energy, and Environment at its meeting of June 17, 2014, recommended adoption of the Director's request (vote 6-0); and

33	WHEREAS, the Committee on Finance, Personnel, and Audit at its meeting of
33 34	June 20, 2014, also recommended adoption of the Director's request (vote 9-0); now,

37	BE IT RESOLVED, that the request for approval of the Beverage Sales Agreement
38	with Bottling Group, LLC / Pepsi Beverages Company be granted; and

40	BE IT FURTHER RESOLVED, that the Director of the Milwaukee County Zoo is
41	hereby authorized and directed to execute, on behalf of Milwaukee County, a Beverage
42	Sales Agreement with Bottling Group, LLC / Pepsi Beverages Company for a period of up to
43	five years (date of execution through February 28, 2019), which will not exceed the
44	budgeted purchasing authority for concession resale items.
