Dear Mayor Barrett,

It has come to my attention that you are in receipt of a Jan. 9 letter to Mayor Barrett and Aldermen from Stewart Wangard, owner of Wangard Partners and 875 E. Wisconsin Avenue. I would like this opportunity to respond to that letter.

Mr. Wangard simply misses the point about the situation at 875 E. Wisconsin Ave. For the past 20 years, SEIU Local 1 and union contractors have established a system that protects workers when building owners change contractors. This system has allowed workers to remain in their buildings at the same rate of pay and benefits with the new contractor.

In fact, one of the janitors who lost her job, Bessie Hervey, had cleaned 875 East for three different companies during her ten years working there. That ended Dec. 1 when Wangard refused to use a new union contractor, instead hiring a nonunion contractor with a completely new staff, being paid poverty wages with little or no benefits.

Mr. Wangard's claim that he chose the new cleaning contractor based on anything but getting the lowest price is highly doubtful. He could've clearly laid out his specifications and expectations to any one of a number of responsible union contractors who perform industry-leading work. Wangard's decision was primarily about squeezing work out of janitors for as little money as possible.

Mr. Wangard's actions not only ruined the lives of 12 workers, he chose a direction that is contrary to how major property owners Downtown have done business for the past twenty years. Mr. Wangard's actions send a message to all owners that it's acceptable to return to 1991 when hiring the lowest bidder with no concern for workers was common practice.

Mr. Wangard's actions are not tolerable in Downtown Milwaukee, where business and labor have been partners toward prosperity, working together to create good, family-supporting jobs. We would like the opportunity to meet with you and discuss this very important issue.

My name is Susanna Fernandez and I live at 2447 S 19th Street. I am writing to you as a constituent regarding my employment at 875 E. Wisconsin as a janitor for Purity Janitorial.

I began working at 875 in December. I was honored and glad to have found work and I took my work seriously as a janitor. My starting pay was \$8.50 and after my probation I along with my fellow co-workers was told we could be eligible for a raise and benefits.

When the probation period ended, I along with my co-workers asked about our raise and benefits including having health care benefits we were told were to be available. After speaking up we got the raise but health care was not made available.

Shortly after we received a raise I along with five other Latino janitors were fired. I wanted to bring what happened to us to your attention so that the building owner knows that there may be a revolving door of janitors who speak up about their benefits and that is not good for Milwaukee. All we wanted was respect and dignity for the work we did.
