Adopted Development Agreement.

In October of 2013, Milwaukee County entered into a development agreement with the Milwaukee Art Museum and the Milwaukee War Memorial as approved in Milwaukee County File# 13-647.

The agreement outlined responsibilities for each party related to the construction of the East Atrium and repairs to the Saarinen Building and Kahler Addition. The agreement set forth a construction budget and obligated Milwaukee County to ten million dollars of funding for the project. Projects outlined in the development agreement are encapsulated within the Milwaukee County Capital project numbers in the below table with their corresponding funding. County contributions over the ten million dollar amount relate to project obligations and responsibilities outlined in the development agreement.
