 AN ORDINANCE**

The County Board of Supervisors of the County of Milwaukee does ordain as follows:

**SECTION 1.** Section 1.11(a) of the Milwaukee County Code of General Ordinances is amended as follows:

1.11. - Standing committees.

(a) As soon as practical, after his/her election, the following standing committees shall be appointed by the chairperson of the county board. Each committee shall consist of five (5) members except as herein otherwise specifically designated.

- (1) Committee on personnel.
- (2) Committee on finance. (Seven (7) members.)
- (3) Committee on audit. (Six (6) members.)
- (4) Committee on health equity, human needs and strategic planning.
- (5) Committee on judiciary, law enforcement and general services.
- (6) Committee on parks and culture. (~~Seven (7) members.~~)
- (7) Committee on transportation and transit.
- (8) Committee on community, environment and economic development.
- (9) Committee on Intergovernmental relations.
- (10) Committee of the whole (Eighteen (18) members, chairperson being the chairperson of the county board and vice-chairperson being the first vice-chairperson of the county board.)


**SECTION 2.** The provisions of this ordinance shall be effective upon passage and publication.
