Subject: Professional Services Agreement Exceeding \$100,000 with Cardno, Inc. for engineering services, final design and development, and an archaeological assessment in the Little Menomonee River Parkway
(PASSIVE REVIEW)

Issue

Implementation of Wisconsin Statutes 59.21(31) with regard to purchase of professional service agreements (under the Milwaukee General ordinance Chapter 56) requires County Board review to award the initial agreement, or fee extension(s) to the original agreement, when the total contractual fee exceeds \$100,000 but is less than \$300,000. The Executive Director of Parks is requesting passive review of a professional service agreement with Cardno, Inc. due to a change in scope that requires a fee revision over \$100,000. The original contract was for engineering services and final design development for Little Menomonee River Parkway and the change of scope includes an archaeological assessment of the LMR Corridor.

Background

In January of 2021 Parks contracted with Cardno, Inc. to complete a habitat management plan and wetland scrape design for the project area known as Sections 4 & 5 of Little Menomonee River Parkway, as part of the grant agreement with the Wisconsin Department of Natural Resources. Parks has requested a change in scope to the Cardno Agreement to include an archeological assessment and survey of the project area. This change of scope is increasing the contract by \$34,430, from \$72,352 to the new amount of \$106,782.

Recommendation

Parks' Executive Director recommends approval of this change of scope and amended fee with Cardon, Inc., for engineering services, final design and development, and an archeological assessment in the Little Menomonee River



Parkway.
