- A. The Zoo Director is requesting the authority to enter into an agreement with Plastination Company Incorporated for an Animal Body Worlds exhibit at the Milwaukee County Zoo (MCZ) from May 4, 2017 to September 4, 2017. The exhibit contract rental totals \$400,000 with an additional \$50,000 for delivery and set-up fees. The Zoo and Plastination will also share the revenue from sales of Body Worlds merchandise. The vendor will receive 70% of the merchandise after sales tax and credit card fees.
- B. The MCZ will pay a deposit of \$100,000 in 2016 with the remaining \$350,000 of the contract to be paid in 2017 including delivery and set-up fees. The agreement also allows the Zoo to sell exhibit branded merchandise and retain 30% of net revenues after sales tax and credit card fees. Total operating cost for the exhibit is \$594,587 with projected revenues of \$740,478 for a tax levy savings of \$145,881.
- C. The 2016 Budget includes \$100,000 for the exhibit deposit to reserve the exhibit for 2017. The MCZ's 2017 Budget Request includes \$594,587 for the total cost of operating the exhibit and contains \$740,468 in revenues for a tax levy savings of \$145,881. General admission fees will be \$10 and \$8 for adults and children, respectively.
