10 AN ORDINANCE

13 The County Board of Supervisors of the County of Milwaukee does ordain as follows:
14

15 SECTION 1. 4.05.05(3)(c). - Buses.
16

17 (3) *Schedules.* Each bus organization, providing scheduled bus service to the airport,
18 shall submit to the airport director a printed schedule or revised schedule showing
19 the times when the buses will arrive at or depart from the airport.
20

21 (a) Mini buses not operating on a fixed schedule shall pay the county, department of
22 public works, airport division six dollars (\$6.00) per day, per vehicle. On the first
23 trip of the day into the airport, each mini bus operator will provide the ground
24 transportation coordinator (GTC) with the bus company name, bus number,
25 license plate number, and company telephone number. The GTC will provide the
26 bus operator with a date stamped ticket authorizing bus operations for the day.
27 Failure to obtain an authorization ticket will result in a penalty fee of ten dollars
28 (\$10.00) per trip being assessed for each trip into the airport until authorization is
29 obtained.

31 (b) Buses seating twenty-four (24) passengers or more not operating on a fixed route
32 or schedule shall pay the Milwaukee County, department of public works, airport
33 division, ten dollars (\$10.00) per day, per vehicle. On the first trip of the day into
34 the airport, each bus operator will provide the ground transportation coordinator
35 (GTC) with the bus company name, bus number, license plate number, and
36 company telephone number. The GTC will provide the bus operator with a date
37 stamped ticket authorizing bus operations for the day. Failure to obtain an
38 authorization ticket will result in a penalty fee of ten dollars (\$10.00) per trip being
39 accessed for each trip into the airport until authorization is obtained.

41 (c) Each bus organization shall pay to the county, department of public works, airport
42 division, ~~fifty cents (\$0.50) per trip. This rate shall increase to seventy five cents~~
43 ~~(\$0.75) effective Jan 1, 2006 and to one dollar (\$1.00) effective Jan 1, 2008 by~~
44 the 15th day of each month, a sum equivalent to one dollar (\$1.00) per trip plus
45 fifty cents (\$0.50) per passenger for each trip made the preceding calendar
46 month.
