
DESCRIPTION OF FISCAL EFFECT

 - A. Seasonal bonus for Highway supervisors mirroring the seasonal bonuses for Highway Maintenance Workers.
 - B. Operating expenses and revenues would increase by \$8,000 and \$6,400 respectively.
 - C. This is a one-time payment of \$200 per month covering a five-month period from November 2018 thru March 2019, totaling \$1,000 per supervisor for eight (8) supervisors and assistant supervisors. The corresponding State revenue offset for this expense is \$6,400 leaving a net County impact of \$1,600.
 - D. Analysis covers all 8 current supervisors and assistant supervisors. Revenue offset assumed to be 80% based on State/County lanes miles.
