### **REQUEST**

From the Executive Director of Milwaukee of County Parks, requesting authorization to enter into a Lease Agreement with UW-Extension for community gardens within Oak Creek Parkway, Kohl, Rainbow, Cupertino, and Underwood Parkway Parks.

### **POLICY**

§ 59.17(2)(b)3., Wis. Stats., states that the "county board may continue to exercise the authority under s. 59.52(6) with regard to land that is zoned as a park...". In the law of property, authority over "land" includes authority over all rights appurtenant to the land.

# **BACKGROUND**

Milwaukee County Parks (Parks) and the UW-Extension community gardens programs have partnered for years to provide gardens that are available to the public. In 2018, Parks and UW Extension entered into an overarching Lease Agreement (Lease) that sought to memorialize the relationship between the two parties at various locations.

Since the original agreement was executed in 2018, UW-Extension has undergone changes in its organizational structure. Later that same year, UW Extension joined UW Madison and became UW Madison Extension. In addition, UW Board's policy is for all agreements to be five years terms, although five-year extensions are allowed if defined in the contract. The 2018 agreement with Parks was for 10 years, which thus requires a new agreement to be created.

The locations that are included are portions of the following, and are also described in the Lease:

- Forest Hill 9 acres located in the Oak Creek Parkway at 1800 East Forest Hill Avenue in Oak Creek
- Kohl Park 46.8 acres located at 7603 West County Line Road in Milwaukee
- Rainbow Park 0.5 acres located at 700 South 119th Street in West Allis
- Cupertino Park 1,630 square feet located at 2000 East Iron Street in Milwaukee
- Firefly Ridge 9 acres located in Underwood Parkway at 10261 Underwood Parkway in Wauwatosa

Two sites that were in the 2018 agreement are not included in this new lease. The site at Moody Park is now managed by COA Youth & Family Centers under a separate agreement. The site at Sherman Park was abandoned by UW Extension in 2020 and was removed by UW Extension in 2022 after Parks determined the site was not compliant with certain provision of the 2018 agreement.

The proposed Lease between Parks and UW-Extension is attached to this file. For reference, the general terms are as follows:

- Use UW-Extension would operate the community garden program in the same manner as is done under the existing 2018 agreement.
- Term 5 years with three (3) additional 5-year extensions if both parties agree.
- Fees
  - UW-Extension will offer educational programs to Milwaukee County residents.
  - UW-Extension will pay water costs and tractor depreciation/maintenance costs to Parks
- Annual Report UW-Extension will provide the County with an annual report of activities at the lease locations no later than March 1 of each term year.
- Litter UW-Extension will be responsible for the daily upkeep of all sites, including trash and litter removal.

Under this relationship, Parks and UW-Extension would continue to collaborate on programming to ensure that all members of the public have access to community garden resources.
