From the Director and Chief Information Officer of Information Management Services Division, Department of Administrative Services (DAS-IMSD) requesting authorization to Abolish 1.0 FTE Senior IT Manager Applications position (Pay Grade 917A) and Create 1.0 FTE IT Manager Applications position (Pay Grade 917E) in 1189 Healthcare Applications, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Information Management Services Division (IMSD), Department of Administrative Services (DAS), identified a need to create one Full-Time Equivalent Information Technology (IT) Manager Applications position to open the pool of qualified candidates to more diverse candidates; and

WHEREAS, it was determined the position of Senior IT Manager Applications required a seasoned, experience manager, who has held management positions previously; and

WHEREAS, the IT Manager Applications position may be staff who demonstrate management skills in previous work, but may not have held a management position; and

WHEREAS, to cover the cost of creating the new position, one vacant position of Senior IT Manager Applications is requested to be abolished; and

WHEREAS, the Senior IT Manager Applications position to be abolished is funded at pay grade 917A, and the IT Manager Applications position to be created is in pay grade 917E, providing salary savings to the department; and

WHEREAS, the Department of Human Resources reviewed this request for a new position to determine the appropriate classification (IT Manager Applications) and pay grade (917E), in a report attached to this file; and

WHEREAS, the Office of Strategy, Budget, and Performance reviewed this request with respect to need, appropriateness, and funding availability as required per Section 59.60(10), Wisconsin State Statutes, and submitted a report included in this file; and

WHEREAS, the Committee on Personnel, at its meeting of March 5, 2024, recommended adoption of File No. 24-294 (vote 5-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board) hereby approves the classification and pay grade recommendation for the position as outlined in the report from the Department of Human Resources hereto attached to this file and summarized below:
