The Department of Administrative Services, Information Management Services Division is requesting the abolishment of 1.0 FTE Database Administrator (Pay Grade NR31) and the creation of 1.0 FTE career ladder Cloud Platform Administrator (Pay Grade NR25) / Senior cloud Platform Administrator (Pay Grade NR31).

Over the last two years the Enterprise Data Services (EDS) team has migrated their work to the Microsoft Azure cloud computing environment, which requires a different skillset than the existing Database Administrator role. The recent departure of the team's Database Administrator presents the opportunity to align the vacant role to the new and future needs of the team.

The Cloud Platform Administrator/Sr Cloud Platform Administrator on the Enterprise Data Services team will manage and optimize our Microsoft cloud-based data platform, with a strong focus on cloud-based data analytics technologies and associated reliability, infrastructure, and security.

B. DAS-IMSD estimates no change in personnel expenditures as the position costs (salary and social security) of the Senior Cloud Platform Administrator is the same pay grade as the currently vacant Database Administrator position.
