 - C. For 2026, the Comptroller's requested budget will include the additional cost of the position, using contractual dollars that were included in the 2025 adopted budget along with abolished positions.
 - D. This fiscal note assumes that the Sr. Grants Compliance Manager position will be filled at the lower quartile of the grade during PP1 2026. If the position is filled at an earlier or later time, or at a different rate than assumed, the savings/costs estimated in this fiscal note will be different.
