A report from the Director, Department of Health and Human Services, requesting the creation of 2.0 FTE Treatment and Resource Navigators in Housing Services, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the Department of Health and Human Services is requesting the creation of two Full-Time Equivalent Treatment and Resource Navigator positions in the Housing Services Division (Housing), to work with individuals and families experiencing homelessness and struggling with substance abuse; and

WHEREAS, the Treatment and Resource Navigator positions will provide homeless outreach services, connections to harm reduction and medically assisted treatment resources, as well as linkages to supportive housing programs; and

WHEREAS, on December 15, 2021, the Milwaukee County Board of Supervisors (County Board) adopted File No. 21-1127, which authorized the Office of Corporation Counsel to enter into Settlement Agreements to receive funds from three Opioid Settlement distributors; and

WHEREAS, on February 2, 2023, the County Board adopted File No. 23-114, which appropriated \$11,456,094 of the Opioid Settlement Funds to finance 15 proposals to address the opioid crisis in Milwaukee County (the County), including the Homeless Outreach Project in Housing in the amount of \$481,570; and

WHEREAS, the Treatment and Resource Navigator positions are necessary to implement this project, and align with the County’s strategic plan to ensure that we can continue in determining what, where, and how we deliver services to advance health equity; and

WHEREAS, the Department of Human Resources has reviewed this position change request, and has determined the appropriate classification (Treatment and Resource Navigator) and pay grade (22), and has submitted a report included in this file; and

WHEREAS, the Office of Strategy, Budget, and Performance has reviewed this request with respect to need, appropriateness, and funding availability as required per Section 59.60(10), Wisconsin State Statutes, and has submitted a report included in this file; and

WHEREAS, the Committee on Personnel, at its meeting of March 7, 2023, recommended adoption of File No. 23-346 (vote 4-0); now, therefore,
