11 The Milwaukee County Board of Supervisors of the County of Milwaukee does
12 ordain as follows:
13

14 **Section 1.** Chapter 60.01 of the Milwaukee County Code of General Ordinances is
15 hereby repealed as follows:
16

17 ~~60.01. - Designation of fees.~~

18 ~~Licensed physicians specializing in psychiatry; licensed physicians and licensed~~
19 ~~psychologists examining persons alleged to be mentally ill, drug dependent, alcoholics~~
20 ~~or developmentally disabled, shall be paid the following fees:~~

22 ~~(1) For examinations. For examinations and certificates by a licensed~~
23 ~~psychiatrist, including clinical interviews, where such examination is made in or~~
24 ~~outside the examiner's office, and all allowance for travel, one hundred dollars~~
25 ~~(\$100.00).~~

27 ~~For examinations. For examinations and certificates by a licensed psychologist,~~
28 ~~including clinical interviews, in or outside the examiner's office, and all allowance~~
29 ~~for travel, seventy dollars (\$70.00).~~

31 ~~(2) For attending and testifying at court hearings. For attending and testifying at~~
32 ~~court hearings by judge or jury relating to s. 51.20, Wis. Stats.:~~
33 ~~For a licensed psychiatrist, one hundred dollars (\$100.00) for the first hour or~~
34 ~~fraction thereof, plus twenty five dollars (\$25.00) for each additional quarter of an~~
35 ~~hour or fraction thereof.~~

37 ~~For a licensed psychologist, seventy dollars (\$70.00) for the first hour or fraction~~
38 ~~thereof, plus seventeen dollars and fifty cents (\$17.50) for each additional quarter~~
39 ~~of an hour or fraction thereof.~~

41 ~~(3) Reexaminations. Fees for examiners for reexaminations, pursuant to s.~~
42 ~~51.20(17), Wis. Stats., shall be the same as provided in subsections (1) and (2).~~

44 ~~(4) Section 971.16, Wis. Stats., examinations. The fees enumerated in~~
45 ~~subsections (1) to (3), inclusive, shall not apply for services rendered under~~
46 ~~appointment pursuant to s. 971.16, Wis. Stats.~~

~~(5) *Claim for services.* Each examiner rendering the services under this chapter shall file a verified claim for payment of his/her fees which shall state:~~

- ~~(a) The title of case and case number.~~
- ~~(b) The purpose of the examination for mental illness, drug dependency, alcoholism and developmentally disabled.~~
- ~~(c) Person examined and place of examination.~~
- ~~(d) Court testimony at trial comprising total hours spent on that case.~~
- ~~(e) The statement that claim is made pursuant to s. 51.20(19), Wis. Stats.~~
- ~~(f) That such claim is for a fee which includes all allowances for travel.~~

Section 2. This ordinance shall be effective upon passage and publication.
