- A. WE Energies needs to install, operate, maintain, repair, replace and extend underground electric services at Nicholson Rd & Ryan Rd in Oak Creek. This project is a double circuit relocation of the Pennsylvania substation by taking existing pole lines and burying them.
  - B. Revenue of \$34,104.00 will be realized based on \$1.60 per square foot for a 21,315 square foot easement. (21,315 ft<sup>2</sup> x \$1.60). Staff time will be required for review of Right of Entry application, but this review time will be compensated by the application fee.
  - C. The revenue for the easement will help meet revenue targets for the budget year
