

From the Director and Chief Information Officer, Information Management Services Division, Department of Administrative Services requesting authorization to Abolish 1.0 Database Administrator and Create 1.0 career ladder Cloud Platform Administrator/Senior Cloud Platform Administrator position, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Information Management Services Division (IMSD), Department of Administrative Services (DAS), identified a need to create 1.0 Full-Time Equivalent (FTE) career-ladder Cloud Platform Administrator/Senior Cloud Platform Administrator position (the Position), to align the organizational design of IMSD, DAS, with current departmental technology needs; and

WHEREAS, over the last two years, the Enterprise Data Services (EDS) team has migrated their work to the Microsoft Azure cloud computing environment, which requires a different skillset than the existing Database Administrator role; and

WHEREAS, the recent departure of the team's Database Administrator presents the opportunity to align the vacant role to the new/future needs of the team; and

WHEREAS, the Position on the EDS team will manage and optimize our Microsoft cloud-based data platform, with a strong focus on cloud-based data analytics technologies and associated reliability, infrastructure, and security; and

WHEREAS, to cover the cost of creating the Position, 1.0 vacant FTE Database Administrator position is requested to be abolished; and

WHEREAS, the Database Administrator position to be abolished is funded at pay grade NR31, and the Position to be created is in pay grades NR25 and NR31, respectively; and

WHEREAS, the Department of Human Resources reviewed this request for a new position to determine the appropriate classification and is recommending Cloud Platform Administrator (pay grade NR25) and Senior Cloud Platform Administrator (pay grade NR31), in a report attached to this file; and

WHEREAS, the Office of Strategy, Budget, and Performance reviewed this request with respect to need, appropriateness, and funding availability, as required per Section 59.60(10), Wisconsin State Statutes, and submitted a report included in this file; and

WHEREAS, the Committee on Personnel, at its meeting of December 2, 2025, recommended adoption of File No. 25-738 (vote 5-0); now, therefore,
