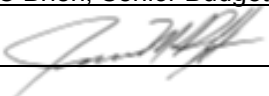
A. The Interim Director of the Department of Health and Human Services (DHHS) is submitting a passive review amendment to a 2018 professional services contract for the psychiatric nursing services program within the Delinquency and Court Services Division (DCSD).

B. The amendment would increase the existing 2018 contract amount of \$165,460, by \$8,130 to \$173,590, and allow for a modest salary increase for nursing staff employed by Alternatives in Psychological Consultation. The amendment would be effective February 1, 2018 and extend to December 31, 2018.

C. There is no 2018 tax levy impact associated with approval of this request as funds sufficient to cover the cost of this amendment are included in the 2018 DHHS Budget.

D. This fiscal note assumes expenditures will not exceed the amount authorized for this professional service contract.
