3 From the Director and Chief Information Officer, Information Management Services
4 Division, Department of Administrative Services (DAS-IMSD), requesting a waiver of
5 Section 9.05(3)(a) of the Milwaukee County Code of General Ordinances, to allow
6 David Siejkowski, former Correctional Officer 1, to perform work for the County as a
7 contractor, by recommending adoption of the following:

9 **A RESOLUTION**

11 WHEREAS, Johnson Controls, Inc. (JCI), is the primary vendor supporting
12 cameras, access control, and other services for several Milwaukee County (the County)
13 departments; and

14
15 WHEREAS, JCI recently lost two employees that supported the County, leaving
16 only one technician available to assist, resulting in staffing issues that are causing
17 delays and challenges to several departments; and

18
19 WHEREAS, David Siejkowski, former Correctional Officer 1, recently left the
20 County on good terms, and was considered a valuable employee; and

21
22 WHEREAS, Mr. Siejkowski served as the Information Management Services
23 Division (IMSD), Department of Administrative Services (DAS), Information
24 Technology (IT) Liaison for various projects, and would work with JCI as a contractor
25 for the County in a different role to serve as an installation and support technician on
26 cameras, access control, and floor control systems for several County departments;
27 and

29 WHEREAS, onboarding Mr. Siejkowski would be an asset to JCI, and thus to the
30 County; and

32 WHEREAS; IMSD-DAS believes the best solution is for Mr. Siejkowski to be
33 allowed to perform work for the County as a contractor for JCI, and to continue to apply
34 specialized IT knowledge on various County IT processes and procedures gained
35 during his tenure as an IMSD IT Liaison and Correctional Officer 1; and

37 WHEREAS, Section 9.05(3)(a) of the Milwaukee County Code of General
38 Ordinances authorizes the Committee on Finance to grant exemptions to the 12-month
39 prohibition of former employees serving as contractual help, if the employee is critical to
40 County operations, such as Mr. Siejkowski; and

42 WHEREAS, the Committee on Finance, at its meeting of December 9, 2021,
43 recommended adoption of File No. 21-1056 (vote 7-0); now, therefore,

45 BE IT RESOLVED, the Committee on Finance hereby grants a waiver of the
46 prohibition found in Section 9.05(3)(a) of the Milwaukee County Code of General
47 Ordinances, to allow the Director and Chief Information Officer, Information
48 Management Services Division, Department of Administrative Services, to retain the
49 services of Mr. David Siejkowski as a contractor working for Johnson Controls, Inc.,
50 within 12-months of leaving Milwaukee County employment.
