A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to approve a settlement of \$4,182 on two Home Repair loans with a total outstanding balance of \$41,821. These Home Repair loans were provided to homeowners Rufus and Dorothy Bester.

B. The terms of the settlement would reflect forgiveness of \$37,639 in outstanding loan debt. To date, the Besters have paid \$2,679 against the total loan amount of \$44,500 for a current outstanding balance of \$41,821. If approved, the final settlement would forgive all but 10 percent of the current outstanding balance, or \$4,182, leaving an outstanding balance of \$37,639.

C. There is no tax levy impact associated with approval of this request. The loan settlement will reduce future HOME program income by \$37,639.

D. This fiscal note contains no assumptions.
