 - A. Milwaukee County Parks is requesting the termination of the agreement between Milwaukee County and City of Milwaukee Police Department that provides free slip rentals and fuel subsidies. With the termination of this agreement, Milwaukee County Parks would be able to charge all tenants for slip rental at McKinley Marina. This would allow for an increase of revenue in both current year and subsequent years.
 - B. Termination would result in an increase in revenues. The 2024 and subsequent year impacts would be similar.
 - C. In 2024, additional revenue would be realized and is requested that that additional expenditure authority for Capital Outlay in the same amount be granted to McKinley Marina in an effort to reinvest the revenues directly into the site. The total impact of this action would be a net effect of \$0 as the additional revenue would offset the additional expense. In subsequent years, the revenue will continue to be relatively similar.
