From the Chief Deputy, Office of the Sheriff, requesting retroactive authorization to amend and extend the agreement with Allied Universal (previously G4S Secure Solutions USA, Inc.), to provide secure transport services for the Milwaukee County Sheriff's Office, by recommending adoption of the following:

A REVISED RESOLUTION

WHEREAS, Allied Universal (Allied) provides intrastate transport services to the Milwaukee County Sheriff (the Sheriff) for Milwaukee County (the County) detainees between the Milwaukee County Jail, the House of Correction, Vel R. Phillips Juvenile Justice Center, all state and county institutions, US Marshal's, health care facilities for medical and mental health appointments, and any other transport of detainees that may be needed; and

WHEREAS, in November of 2020, a request for proposals (RFP # 98200018) was issued by the Milwaukee County Sheriff's Office to provide secured transportation services for the Sheriff with responses due on February 17, 2021; and

WHEREAS, following selection of a proposal, the winning respondent, G4S Secure Solutions, Inc., (G4S), indicated a request for a price increase which invalidated the award of RFP #98200018; and

WHEREAS, the County intends to re-issue the RFP; and

WHEREAS, On or around April 6, 2021, Allied acquired G4S, and all obligations held by G4S Secure Solutions prior to acquisition, including the Service Agreement (the Agreement) with the County; and

WHEREAS, Allied shall invoice the County on a monthly basis for the actual hours worked, based on the bill rates identified in this Agreement, Section 2: Scope of Services; and

WHEREAS, to accommodate market fluctuations because of Coronavirus Disease pandemic, the administrative cost of personnel amounts to \$1,809,808, and the equipment cost is \$75,306.10 per-month for equipment: and

WHEREAS, the total compensation to be paid to Allied for services shall be capped at \$2,713,481.20 for 2022, unless agreed to by the County in writing; and

WHEREAS, the Committee on Finance, at its meeting of March 17, 2022, recommended adoption of File No. 22-318 (vote 5-1); now, therefore,

45 BE IT RESOLVED, the Office of the Sheriff is hereby authorized to retroactively
46 amend and extend Amendment 3 to the Service agreement with Allied Universal in an
47 amount not-to-exceed \$2,713,481.20, on a month-to-month basis beginning on
48 January 1, 2022, and continuing at Milwaukee County's sole option until the award of a
49 new contract, and the completion of any transition period under any Request for
50 Proposals for secure transportation services.
