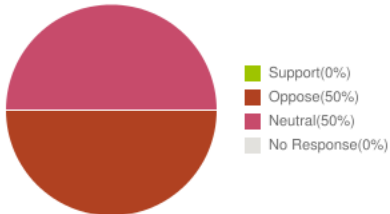

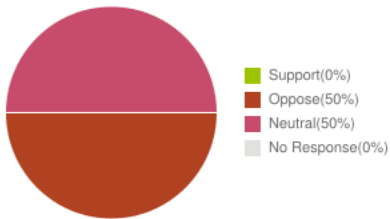

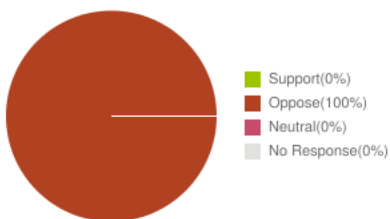

The cost of Milwaukee County Parks staff time to plan, operate, promote and ensure gambling law compliance for

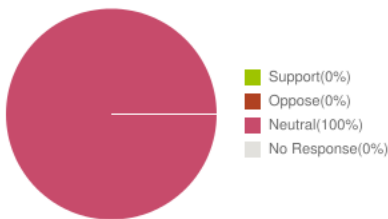

While I appreciate the focus on creating additional revenue streams for our parks, as a seasoned fundraiser in Milwaukee, I know that a 50/50 raffle is not the most effective method and I believe we should focus our collective energies elsewhere.

I strongly recommend Milwaukee Parks Foundation & Milwaukee County Parks continue to work together to focus on fundraising strategies that research demonstrates to be more effective, including but not limited to: pursuing major donors, foundation and corporate support, special events, building an individual donor base, and more.

On behalf of the Milwaukee Preservation Alliance, I want to thank the Domes Project Team for their continued efforts to move toward long term solutions for this incredibly important County icon and the Parks Committee for your oversight of the process and stewardship of our beloved parks.

We eagerly anticipate the results of the legal analysis of the Task Force Plan as well as the financial stack review, including a capital funding stack that could be used to fund the project, and urge these reports to be made public and added to the file as soon as they are available so the public has ample opportunity to review the findings.

We also look forward to the results of Phase 2 of the Glazing Study and request again that Phase 1 of this study be made public and added to the file. Recognizing that supply chain issues may delay the completion of the mock-up of the proposed \$20 million restoration solution, we hope that decision-making processes, including public engagement, will not be unnecessarily delayed as a result.

We are also very appreciative of the opportunity for the public to share their views on the future of this important public asset. We hope that information on the details of the public engagement plan will be shared with the public as soon as possible, that engagement will be able to begin as soon as possible following blackout periods, and most importantly that it will be robust and transparent. We at MPA certainly want to be an ally in helping the public engage with the future of the Domes.

The Domes are an internationally unique treasure that provide health benefits year-round to all residents of the County. A long-term preservation solution at the Domes, which has been consistently supported by the public, would be a meaningful step toward the County's stated goal of being the healthiest County in Wisconsin by achieving racial equity. As the process continues, we urge the Committee to seriously consider the health, environmental, economic, equity, and cultural benefits the long-term preservation of the Domes and revitalization of Mitchell Park can provide to the County for decades to come. Similar projects have been accomplished very successfully to these ends in cities around the country, and I know Milwaukee is capable of seeing the same
