**BACKGROUND**

The Department of Human Resources in accordance with State Statute 111.70 and Milwaukee County General Ordinances 79 & 80 are providing the following documents to the Committee for review:

- 1) The Memorandum of Agreement (MOA) between the County and the Milwaukee Building and Construction Trades Council, AFL-CIO;
- 2) A notification from the Milwaukee Building and Construction Trades Council, AFL-CIO that the MOA was ratified by the membership;
- 3) A draft Resolution approving the MOA;
- 4) A fiscal note that has been prepared by the Office of the Comptroller.

### **FISCAL EFFECT**

The Memorandum of Agreement terminates on December 31, 2023 and provides a one percent increase in wages of bargaining unit employees, effective Pay Period 8, 2023 (April 2, 2023).

### **TERMS**

This Agreement is to take effect on January 1, 2023. Unless otherwise modified or extended by mutual agreement of the parties, this Agreement shall expire on December 31, 2023.
