 - A. Combined Court Related Operations is seeking to abolish 2 vacant Sr. Assistant Clerical positions (NR14) and create 2 Specialists Clerical Cts (NR14) positions. The Clerical Specialist positions is a vital position to the departments operations in servicing the needs of the public. The creation of these two positions will meet the departmental needs associated with the performance of senior level clerical work, including preparation of CCAP case files, generating and processing documents, scheduling court dates, creating and clearing warrants, verifying accuracy of data, maintaining the Court substitution line and records, and coordinating daily court calendar and hearings to ensure that all parties are present virtually or in-person. Additionally, it will allow the department more flexibility in assigning day-to-day clerical duties which require an advanced skillset.
 - B. Both positions are in the same pay grade so there is no fiscal impact to the department or County.
