Subject: TAP Grant Trail Bicycle Signage – 2018 **Budget Amendment (1A028). (INFORMATION)**

Background

While the City of Milwaukee and Milwaukee County parks are home to a world-class trail network, one of key features missing from the system is integrated wayfinding between jurisdictions, networks, and facility types.

Current signage for bicycle and trail facilities between the City of Milwaukee and Milwaukee County is inconsistent and incomplete, and as a result, the travelling public cannot access important safety and wayfinding information. This project will lay the groundwork for a seamless, coordinated signage system that makes City, County, and State trail facilities easy for users to find and navigate. The coordinated signage plan will include facility identification, wayfinding, and directional/guide signage, especially where there are connections between on- and off-street facilities.
