Approval of this resolution will call on Wisconsin state policymakers to adopt the Governor's provision in the Executive 2019-2021 Wisconsin State Budget on marijuana decriminalization and medical marijuana legalization, pursuant to the guidance of Milwaukee County voters in an advisory referendum from the 2018 General Election on the subject of legalization, regulation, and taxation of marijuana.
 - B. There are no direct costs associated with this resolution. Existing staff time would be needed to communicate the contents of the resolution to state policymakers.
 - C. No budgetary impacts are expected in this or subsequent years. The resolution would not authorize the expenditure of any additional funds.
