3 From the Director, Department of Parks, Recreation, and Culture, requesting retroactive  
4 authorization to execute a Lease Agreement with the Southeastern Hockey Association  
5 of Wisconsin for the Wilson Park Recreation Center, totaling \$1,800 per year, for a  
6 three-year term, effective July 1, 2016, through July 30, 2019, with two one-year  
7 renewal options, by recommending adoption of the following:

9 **A RESOLUTION**

11 WHEREAS, the Southeastern Hockey Association of Wisconsin (SHAW) is a  
12 non-profit 501(c)(3) organization whose mission is to introduce the youths in our area to  
13 the game of hockey while providing a positive learning experience in a way that helps  
14 them develop both inside and outside the rink; and  
15

16 WHEREAS, SHAW believes that hockey is a sport that helps develop character,  
17 through sportsmanship, respect, teamwork, and self-discipline; and  
18

19 WHEREAS, SHAW has been a significant partner of the Department of Parks,  
20 Recreation, and Culture for over the last ten years, renting significant ice time at Wilson  
21 Park Recreation Center for their programming and hockey league; and  
22

23 WHEREAS, they have coordinated this rental through the Recreation Center Unit  
24 Coordinator at Wilson Park; and  
25

26 WHEREAS, this Agreement is for the right to use an office and storage space at  
27 the Wilson Park Recreation Center and host hockey practices and sports activities for  
28 youths; and  
29

30 WHEREAS, the dates and times of said activities and practices shall be  
31 coordinated with the Park Recreation Center Unit Coordinator at Wilson Park, but may  
32 only occur during the normal operating hours of Wilson Park Recreation Center; and  
33

34 WHEREAS, the initial term of this Agreement shall be for a three-year period  
35 made retroactive to July 1, 2016, and ending June 30, 2019; and  
36

37 WHEREAS, the Agreement shall automatically renew, if both parties mutually  
38 agree for two additional one-year periods; and  
39

40 WHEREAS, SHAW shall pay a yearly rent of \$1800; and  
41

42 WHEREAS, the Committee on Parks, Energy, and Environment, at its meeting of  
43 December 6, 2016, recommended adoption of the Director's request (vote 4-0); now,  
44 therefore,

45           BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby  
46 authorizes the Director, Department of Parks, Recreation, and Culture, to retroactively  
47 execute a Wilson Park Recreation Center Lease Agreement for the period effective  
48 July 1, 2016, through June 30, 2019, with the Southeastern Hockey Association of  
49 Wisconsin.
