(ITEM ) From the Director, Office of Performance, Strategy & Budget, Department of Administrative Services, requesting authorization to create Chapter XX of the Milwaukee County Code of General Ordinances to collect a Vehicle Registration Fee, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, Wisconsin Stats §341.35 allows municipalities and counties to enact an annual flat vehicle registration fee, which fees may only be used for transportation related purposes; and

WHEREAS, without locating an additional source of funds the County Department of Transportation will not be able to sustain its current levels of operation and capital repairs; now, therefore,

BE IT RESOLVED, that in accordance with Wisconsin Stats §341.35 the Milwaukee County Board of Supervisors adopts a county vehicle registration fee; and

BE IT FURTHER RESOLVED, that the Milwaukee County Board of Supervisors hereby creates Chapter XX of the Milwaukee County Code of General Ordinances by adopting the following:

**AN ORDINANCE**

The County Board of Supervisors of the County of Milwaukee does ordain as follows:

**Section 1.**

Chapter XX of the Milwaukee County Code of General Ordinances is hereby created as follows:

**VEHICLE REGISTRATION FEE PROGRAM**

XX-XX. Authority

This ordinance is adopted pursuant to the authority granted by Wisconsin §341.35.

42 XX-XX. Purpose

43 The purpose of this ordinance is to provide Milwaukee County with a source of  
44 funds, in addition to other funding sources, for eligible transportation related activities  
45 defined within Wisconsin §341.35.

47 XX-XX. Definition.

48 In this section, "motor vehicle" means an automobile or motor truck registered  
49 under §341.25(1)(c), Wis. Stats, at a gross weight of not more than 8,000 pounds, that is  
50 registered in this state and is customarily kept in Milwaukee County.

51

52 XX-XX. Annual registration fee.

53 At the time a motor vehicle is first registered or at the time of registration  
54 renewal, the applicant shall pay a county vehicle registration fee of \$60. This fee is in  
55 addition to other fees required by Wisconsin Statutes Chapter 341. The Wisconsin  
56 Department of Transportation (DOT) shall collect the fee. Use of funds generated by this  
57 registration fee shall be restricted to supporting Milwaukee County transportation  
58 activities.

60 XX-XX. Exemptions.

61 The following motor vehicles are exempt from the annual vehicle registration fee:

62

63 (a) All vehicles exempted by Wisconsin Statutes Chapter 341 from payment of a  
64 state vehicle registration fee.

65

66 (b) All vehicles registered by the state under Wisconsin Statutes § 341.26 for a fee  
67 of \$5.

68

69 XX-XX. Replacements.

70 No county vehicle registration fee may be imposed on a motor vehicle which is a  
71 replacement for a motor vehicle for which a current county vehicle registration fee has  
72 been paid.

73

74 XX-XX. Administrative costs.

75 The Wisconsin Department of Transportation shall retain a portion of the moneys  
76 collected under this section equal to the actual administrative costs related to the  
77 collection of these fees.

78

79 **Section 2.**

80 The provisions of this Ordinance shall become effective upon passage.

81

82           BE IT FURTHER RESOLVED, that the Milwaukee County Board of Supervisors  
83 hereby directs the Office of Governmental Affairs to lobby the State of Wisconsin  
84 legislature to modify Wisconsin Statutes Chapter 341 to base the Vehicle Registration  
85 Fee on the value of the vehicle and also to fully fund local transportation needs.

87           BE IT FURTHER RESOLVED, that the County Executive shall convene a  
88 public/private task force to consider ways to moderate the impact on low income  
89 households.
