Here is my question.

Based on your funding amounts per zone and the number of applications expected to be collected in each zone there is a huge discrepancy in the funds received per application. Please see the table below:

Zone	Funding Per Application
1	\$24.54
2	\$27.22
3	\$47.21
4	\$26.85
5	\$50.56
6	\$51.66

Can you please explain the rationale behind the determination of the funding levels for each zone? You show the largest three zones (1,2, and 4) representing 80% of the applications processed in the county receiving only 68% of the available funds.
