Subject: A Request from the Director of the Office of Government Affairs for Passive Review of a Professional Services Agreement with Broydrick and Associates with a total contractual fee of \$40,000.

REQUEST

Request to enter a 2026 professional services contract with Broydrick and Associates ("Broydrick") with a contractual fee of \$40,000. Past professional services contracts with Broydrick bring the aggregate value in the last several years to over \$100,000, but less than \$300,000.

POLICY

Per Wis. Stat. 59.52(31), the Director of the Office of Government Affairs is requesting passive review authorization for this professional services contract.

BACKGROUND

The Office of Government Affairs will, on occasion, service contracts with government affairs services providers in order to better represent Milwaukee County's interests at various levels of government. One such service provider is Broydrick, who specialize in federal government affairs in Washington, D.C. The Office of Government Affairs has utilized Broydrick over the last five years and the firm was selected based on its significant experience navigating the intricacies of the federal landscape and political process.

The 2026 contract allows Broydrick, in collaboration with the Office of Government Affairs, to continue helping Milwaukee County respond to systemic funding issues and capital backlog by executing an engagement strategy that leverages Congressionally Directed Spending and other federal opportunities for additional funding and regulatory changes by engaging Congressional leaders, Wisconsin's Congressional delegation, and the administration, including federal agencies.

The continuing engagement with Broydrick has allowed the Office of Government Affairs, in partnership with other departments, to be the most successful local government in the state relative to number of projects awarded funding through the Congressionally Directed Spending process.
