The Executive Zoo Director is requesting to abolish one position of Marketing and Events Manager to create one position of Events Manager to provide greater support to the events department, as the Zoo has added events in recent years and will continue to create additional revenue and attendance experiences.
- B. The creation of one position of Events Manager will be offset with the abolishment of one position of Marketing and Events Manager. Depending on the starting hourly rate of the new Events Manager, salary savings may occur.
- C. There are no budget impacts in 2024 as the position will not be filled until 2025. Sufficient funds are budgeted in the 2025 budget for an events manager role.
