- A. This report from the Director, Department of Health and Human Services, requests authorization to retroactively amend 2023 contracts per-meal reimbursement costs with Aramark Correctional Services and D & S Food Services Inc. for the meals these caterers prepare for the Senior Meal Program.
- B. The 2023 catering and food budget for this change will remain unchanged with this per-meal price increase. And the total value of the contract with each vendor in 2023 (Aramark Correctional Services: \$1,302,500; and D & S Food Services Inc.: \$1,377,500) will remain unchanged.
- C. This amendment will have no tax levy impact.
- D. No assumptions were made.
