**A RESOLUTION**

WHEREAS, the prior incumbent in the Air Service Director position retired at the end of 2024; and

WHEREAS, the prior incumbent had extensive experience at the Milwaukee Mitchell International Airport and was able to shape the position based on these unique skills; and

WHEREAS, over the course of 2025, the position has been evaluated to determine the evolving needs of the position and to properly reclassify the position going forward; and

WHEREAS, based on recent meetings with airlines and conversations with the air-service consultant team, the needs of the position have shifted to be more data driven; and

WHEREAS, due to this insight, the position is better classified as Airport Air Service Manager; and

WHEREAS, the Department of Human Resources has reviewed the abolish/create request and determined the appropriate classification (Airport Air Service Manager) and pay grade (NR28), and has submitted a report included in this file; and

WHEREAS, the Office of Strategy, Budget, and Performance has reviewed this request with respect to need, appropriateness, and funding availability, as required per Section 59.60(10), Wisconsin State Statutes, and has submitted a report included in this file; and

WHEREAS, the Committee on Personnel, at its meeting of March 3, 2026, recommended adoption of File No. 26-320 (vote 4-0); now, therefore,
