Approval of this contract will authorize the Superintendent of the House of Correction (HOC), to amend the current contract with Employ Milwaukee for a third year of the contract and increase the do not exceed amount by \$38,000. A total of \$20,663 of the contract will be reimbursed through the Edward Byrne Memorial Justice Assistance Grant (see File No. 18-670). Remaining funds have been budgeted for this contract in the 2019 Adopted Budget. The HOC has extended the contract already through March 31, 2019 and total spent on the contract since August 11, 2017 is \$88,000. This extension would increase the do not exceed clause to a total of \$126,000.
