A RESOLUTION

WHEREAS, the creation of positions in the 2014 Adopted Budget requires action by the Committee on Finance, Personnel, and Audit to establish the classification and rate of compensation for those positions; and

WHEREAS, at its meeting of January 30, 2014, the Committee on Finance, Personnel, and Audit took separate action (File 14-84) on the Department of Human Resources position listing and adopted all positions contained in the following departmental Org. Units: 6300-Department of Health and Human Services Behavioral Health Division, 7900-Department on Aging, 7990-Department of Family Care, and 8000-Department of Health and Human Services (vote 7-2); and

WHEREAS, at its meeting of January 30, 2014, the Committee on Finance, Personnel, and Audit Laid Over to the Call of the Chair (File 14-84) all positions contained in the following departmental Org. Units: 1151-Department of Administrative Services (DAS)-Administration and Fiscal Affairs, 1152-DAS-Procurement, 1192-DAS-Economic Development, 3700-Office of the Comptroller, 4000-Office of the Sheriff, 4300-House of Correction, 4900-Medical Examiner, 5040-Department of Transportation-Airport, and 5700-DAS-Facilities Management; and

WHEREAS, at its meeting of April 17, 2014, the Committee on Finance, Personnel, and Audit reviewed the list of positions that were Laid Over to the Call of the Chair on January 30, 2014, and recommended for approval (vote 5-0) one position of Forensic Investigator in Org. Unit 4900-Medical Examiner and recommended that the balance of the positions be Laid Over for One Meeting (vote 5-0); and

WHEREAS, at its meeting of May 15, 2014, the Committee on Finance, Personnel, and Audit reviewed the list of positions that were Laid Over for One Cycle on April 17, 2014, and recommended for approval (vote 8-0) the balance of the positions; now, therefore,
