This resolution authorizes the Executive Director, Department on Aging, to amend a 2018 purchase of service contracts with Legal Action to provide Medicare related outreach services to Milwaukee County seniors age 60 or older.

The County received additional, previously unbudgeted MIPPA and SHIP grants which completely offset this additional expenditure.

The adoption of this resolution will not require the expenditure of any County tax levy not previously authorized in the 2018 Adopted Budget. No assumptions or interpretations were made.

This resolution has no fiscal impact on 2018 other than the allocation of staff time required to prepare the accompanying report and resolution.
