BACKGROUND

Youth Commission Update:

The 2025 Term Co-Chairs are:

The 2025 Term Adult Advisors are:

- Nicolasa Alamilla, Appointed by the Milwaukee County Youth Commission

- Sharlen Moore, Appointed by County Executive Crowley
- Nikki Todd, Re-appointed by County Executive Crowley
- Supervisor Kathleen Vincent, Re-appointed by Chairwoman Nicholson

In December 2024, the Board of Supervisors voted to <u>amend Chapter 106</u>- County Commission on Youth of the Milwaukee County Code of General Ordinances (MCGO), to modify the term of office for youth commissioners to better align with the school calendar year. Due to this change, there are different terms in 2025 and 2026 for each district as we transition from the previous term dates of January 2-January 1. Applications for districts with the following term start dates have been open since March and will close on Friday, May 30, 2025:

- September 1, 2025;
- January 2, 2026; and
- September 1, 2026.

Since its last report to the Board of Supervisors in September 2024, the Youth Commission has engaged in the following activities:

- Honor Flight Welcome Home Celebration (at the invitation of Sup. Capriolo)- November 2, 2024
- Q4 Volunteer Opportunity at The Gathering- November 16, 2024
- 2024 Term Completion Ceremony- December 18, 2024
- 2025 Term Swearing-In Ceremony & Reception- January 15, 2025
- Dr. Martin Luther King, Jr. Day on the North Shore event (at the invitation of Sup. O'Connor)- January 20, 2025
- State of the County Address Remarks (at the invitation of County Executive Crowley)-March 26, 2025
- Day of Advocacy- April 9, 2025

Members of the Milwaukee County Youth Commission were joined by delegates from their districts as they held their first Day of Advocacy. Almost 30 delegates met with

members of the Wisconsin State Legislature who represent Milwaukee County, Governor Evers' policy staff, and Department of Public Instruction (DPI) leaders to discuss policy proposals in the Youth Commission's three identified priority areas of youth homelessness, youth mental well-being, and youth civic engagement.

2025 Take a Child to Work Day- April 24, 2025

There were over 150 participants in the second annual Take a Child to Work Day event, held at Boerner Botanical Gardens, co-sponsored by the Youth Commission and Dept, of Human Resources. This year's theme, "Building a Strong Future," allowed participants to go behind the scenes of Milwaukee County's infrastructure, with access to 12 fleet vehicles, and engage in hands-on activities developed by 15 departments and offices.

 Released application for the 2025 "Excellence in Youth Impact Awards" to recognize three organizations for outstanding work in each of the Commission's three priority areas- April 30, 2025

In February 2025, the Milwaukee County Board of Supervisors added a position for Milwaukee County Youth Commission member to the City-County Advisory Board on Climate and Economic Equity, to be appointed by the County Board Chairperson.

In April 2024, the Youth Commission experienced a staff transition. Nikki Todd, who helped to implement the Youth Commission in 2022 and has managed its operations since 2023, transitioned to a new role as Senior Policy Manager. Youth Commission operations will continue to be managed within the Project Management Office by Bess Earl, Project Manager, and Julia Balestrieri, Administrative Coordinator.

The resolution to re-establish the Milwaukee County Youth Commission was authored by Chairwoman Nicholson and County Executive David Crowley and co-sponsored by Supervisors Sequanna Taylor, Martin, Clancy, Vincent, and Burgelis. It was passed unanimously by both the Committee on Intergovernmental Relations and the Board of Supervisors in May 2022.
