

From the Comptroller, Office of the Comptroller, requesting to abolish 1.0 FTE Associate Accountant, Pay Grade NR17 (vacant) and creating 1.0 FTE Supervisor Accounting, Pay Grade NR25, by recommending adoption of the following:

### A RESOLUTION

WHEREAS, the 2025 Adopted Budget includes 1.0 Full-Time Equivalent (FTE) Associate Accountant position (pay grade NR17), which is vacant, and this position would be abolished to create 1.0 FTE Accounting Supervisor position (pay grade NR25); and

WHEREAS, the Central Accounting Division (CAD), Office of the Comptroller (Comptroller), is responsible for producing Milwaukee County's (the County) Annual Comprehensive Financial Report (ACFR), which is critical to the County accessing State of Wisconsin (the State) and Federal funds; and

WHEREAS, CAD, Comptroller, has identified a need for an individual who can produce comprehensive exhibits, including management-discussion analysis, footnotes, and statistical sections for the ACFR, and monitor County compliance with all local Ordinances, State and Federal Governments, Generally Accepted Accounting Principles, and Governmental Accounting Standards Board proclamations; and

WHEREAS, this position will also manage difficult or complex work assignments, including, but not limited to: consolidations of Milwaukee County Transit System statements, pension and healthcare analysis, reserve analysis, and fiscal reporting, using initiative and ingenuity where oftentimes there is little precedent; and

WHEREAS, the Department of Human Resources has reviewed this request for a new position or additional staffing to determine the appropriate classification (Supervisor Accounting) and pay grade (NR25), and has submitted a report included in this file; and

WHEREAS, the Office of Strategy, Budget, and Performance has reviewed this request with respect to need, appropriateness, and funding availability, as required per Section 59.60(10), Wisconsin State Statutes, and has submitted a report included in this file; and

WHEREAS, the Committee on Personnel, at its meeting of June 10, 2025, recommended adoption of File No. 25-391 (vote 5-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board) hereby approves the classification and pay recommendation for the position, as outlined in the report hereto attached to this file and summarized below:
