(ITEM ) From the Director, Department of Parks, Recreation, and Culture, requesting authorization to execute fee increases for various uses of select Milwaukee County Park facilities for 2016, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the 2016 Adopted Budget, through Amendment 1A045, requires that the Department of Parks, Recreation, and Culture (DPRC) fees remain at 2015 levels, with discretion given to the Director, DPRC, to reduce fees, and requires the DPRC to seek approval for any fee increases for 2016; and

WHEREAS, the DPRC reviews and adjusts fees annually based primarily on market analysis and consistency, while providing new opportunities to patrons; and

WHEREAS, the Committee on Finance, Personnel, and Audit, at its meeting of December 10, 2015, recommended adoption of the Director's request (vote 7-0); and

WHEREAS, the Committee on Parks, Energy, and Environment, at its meeting of January 26, 2016, recommended adoption of the Director's request (vote 4-2); and

WHEREAS, the Committee on Parks, Energy, and Environment, at its meeting of March 8, 2016, recommended adoption of the Director's request (vote 4-2); and

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes the Director, Department of Parks, Recreation, and Culture to implement the 2016 fee increases as listed on the following page:
