A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to allocate approximately \$966,350 in anticipated 2020 Community Development Block Grant (CDBG) COVID funding.

B. Earlier this year, DHHS received an initial allocation of \$992,237 in CDBG funding from the Coronavirus Aid, Relief, and Economic Security (CARES) Act to allow for an immediate response to the COVID-19 crisis in our community. The allocation of these funds was approved by the County Board under File No. 20-353. For this second allocation of \$966,350, the Housing Division is proposing the following uses for these funds:

COVID Isolation Facility Expenses:	\$323,090
Division of Aging Meal Delivery:	\$250,000
Small Business Loans:	\$200,000
Administration (20 percent):	\$193,260
<b>Total Allocation:</b>	<b>\$966,350</b>
