Report from the Director, Department of Health and Human Services, requesting authorization to execute non-professional service contracts with caterers which support the Senior Dining Program from January 1, 2024 through December 31, 2024 at a cost of \$3,121,680, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the Area Agency on Aging is mandated to administer programs within Milwaukee County (the County) through Title III-C, Older Americans Act (the Act) that support nutrition programs, which include Meals on Wheels, the Dine-Out Program, and congregate nutrition programs at Senior Centers; and

WHEREAS, the Senior Dining program (the Program), not only helps directly alleviate food insecurity, but also promotes the health and well-being of older adults by incorporating wellness checks into meal delivery, and encourages visits to a select group of locally owned restaurants through the Dine-Out Program, and provides meals at 14 sites around the County that provide programming, and other activities for older adults; and

WHEREAS, through the Program, older adult diners are presented with nutritious and delicious meals that are developed and supervised to be tailored to the nutritional needs of older adults, with increasingly diverse offerings across the County; and

WHEREAS, consistent with Section 59.52(31)(c), Wisconsin State Statutes, Aging and Disability Services, Department of Health and Human Services, must, on behalf of the Commission on Aging, bring contracts with a value or aggregate value of \$300,000 or more to the Milwaukee County Board of Supervisors for authorization; and

WHEREAS, the Committee on Finance, at its meeting of December 14, 2023, recommended adoption of File No. 23-963 (vote 5-0); now, therefore,
