Implementation of Wisconsin Statutes 59.21(31) with regard to purchase of professional service agreements (under the Milwaukee General Ordinance Chapter 56) for Capital projects requires County Board review to award the initial agreement, or fee extension(s) to the original agreement, when the total contractual fee exceeds \$100,000 but is less than \$300,000. As a part of the Consolidated Facilities Planning project - Phase 3, the Director of the Department of Administration (DAS) is planning to execute a professional service agreement with Hammel, Green and Abrahamson, Inc. (HGA) to assist Milwaukee County in Milwaukee County Courthouse Program Statement.
- B. The selected Design Team has submitted a proposal that has been reviewed and accepted by the AE&ES Section of DAS-FM. The total proposed cost of the professional services agreement is \$281,000.00.
- C. There are sufficient funds allocated specifically for this purpose by the adopted 2015 budget in the CFP Phase 3 funding in DAS Facilities Management operating budget.
