

9 The County Board of Supervisors of the County of Milwaukee does ordain as follows:

10
11 SECTION 1. Chapter 69 of the Milwaukee County Code of General Ordinances is
12 hereby amended as follows:

13
14 Section 69.02. – Parking prohibited in designated areas.

15
16 No person shall stop or leave any vehicle standing in any of the following places,
17 except temporarily, for the purpose of and while actually engaged in loading or
18 unloading or in receiving or discharging passengers and while the vehicle is attended by
19 a licensed operator:

- 20 (1) College Avenue (C.T.H. 'ZZ')
21 (a) Between the limits of South 20th Street and South 27th Street.
22 (b) On the south side, from a point four hundred fifty (450) feet east of
23 South 35th Street to the limits of South 27th Street.
24 (2) South 76th Street (C.T.H. 'U')
25 (a) Between the limits of West Grange Avenue and West Layton Avenue.
26 (b) Between the limits of West Ryan Road and a point three-fourths (¾) of
27 a mile north of Ryan Road.
28 (c) Along the west side of South 76th Street (C.T.H. U) from a point six
29 hundred fifty (650) feet south of the south line of West Ryan Road to a
30 point nine hundred seventy-five (975) feet south of the south line of
31 West Ryan Road.
32 (d) Along the west side of South 76th Street (C.T.H. U) from a point one
33 thousand seventy-five (1,075) feet south of the south line of West Ryan
34 Road to a point one thousand two hundred (1,200) feet south of the
35 south line of West Ryan Road.
36 (3) Good Hope Road (C.T.H. 'PP')
37 (a) Between the limits of North Port Washington Road and North Pierron
38 Road.
39 (4) South 68th Street (C.T.H. 'A')
40 (a) Between the limits of West Ryan Road and a point three-fourths (¾) of
41 a mile north of Ryan Road.
42 (5) West Beloit Road (C.T.H. 'T')
43 (a) North side of the road from the intersection of South 108th Street
44 (S.T.H. 100) to a point five hundred seventy (570) feet east of South
45 108th Street.
46
47 (6) West Layton Avenue (C.T.H. 'Y')
48 (a) From the limits of South 60th Street to a point eight hundred twenty-
49 five (825) feet east of South 60th Street.
50 (b) On the south side of the street from the limits of South 49th Street to
51 the limits of South 48th Street.
52 (7) South 92nd Street (C.T.H. 'N')
53 (a) On the west side of the street from the limits of West Howard Avenue
54 to the limits of West Waterford Avenue.
55 (8) West Rawson Avenue (C.T.H. 'BB').
56 (a) On both sides of the street from South 27th Street to South Howell
57 Avenue.

59 SECTION 2. The provisions of this Ordinance shall become effective upon passage and
60 publication.
