REQUEST

The Office of Strategy, Budget and Performance (SBP) requesting approval to create 1.0 FTE Program & Evaluation Analyst in paygrade 28M.

POLICY

Milwaukee County Ordinance 17.28: The maximum number of positions and/or the maximum number of employee hours in a given classification are approved as part of the annual adopted budget. Changes to the authorized number of positions outside of the budget process require approval by the Milwaukee County Board of Supervisors.

BACKGROUND

The Program and Evaluation Analyst would be located within the Project Management Office (PMO), which administers the American Rescue Plan Act (ARPA) county-wide evaluation strategy. The Milwaukee County Board of Supervisors approved \$3,389,000 for Milwaukee County ARPA Evaluation (22-560, 24-535 & 24-755). This project established an evaluation plan to evaluate the 73 ARPA projects to understand and communicate return on investment, progress toward goals and intended outcomes, and impact of ARPA investments on residents, communities, and the County's fiscal health. The evaluation will show to what extent and how projects achieved their goals and how those achievements ladder up to Milwaukee County's strategic objectives. The Program and Evaluation Analyst position will serve in a critical role to implement and sustain the evaluation plan while supporting employees and departments to replicate this evaluation strategy in other service areas.

The Program and Evaluation Analyst position was not included in the 2025 Budget because the position is currently funded by revenue made possible by ARPA as part of the ARPA Evaluation project. This position will support the implementation of the Milwaukee County ARPA Evaluation Framework and county-wide evaluation activities.

Funding for this position would be allocated from the Milwaukee County ARPA Evaluation project that was approved by the Board on June 2, 2022. This position will have a net total tax levy impact of \$0.
