Ms. Jennifer Sandy, National Trust for Historic Preservation, appeared and spoke for information only regarding this item. Ms. Sandy provided a PowerPoint presentation, which is attached to this file as "19-55 PowerPoint."

Ms. Sandy explained that the Mitchell Park Conservatory Domes may be eligible for Historic Tax Credits, and provided various scenarios in which the project could leverage that source of funding.

4 Report and Discussion of the Resolution Implementing the Domes Task Force Request for Transfer of Funds and Next Steps. (INFORMATION ONLY)

There were no appearances.

Chairman Lynch summarized the legislative activity on the interim report and request for funding submitted to the Committee on Parks, Energy, and Environment, as File No. 19-129. The Chairman also provided a synopsis of the resolution introduced by Supervisor Lipscomb, Sr., providing \$120,000 to the Task Force for the Phase III Future Path and Feasibility Study. The Chairman emphasized the renewed importance of completing the concrete and glazing studies, and the mandate from the Milwaukee County Board of Supervisors to submit the Task Force's final recommendations for consideration in the September 2019 legislative cycle.

5 Update on the Status of the Concrete and Glazing System Rehabilitation Methods Study. (INFORMATION ONLY)

Julie Bastin, Project Manager, Architecture, Engineering, and Environmental Services Section, Facilities Management Division, Department of Administrative Services

Task Force Member Carron distributed materials to Task Force members, which are attached to File No. 19-102, Item 1 on this agenda, as "Summary Report on Domes Material Testing."

Ms. Bastin provided a synopsis of the report. Ms. Bastin indicated that a contractor has been engaged to complete the concrete study, which is anticipated to be completed in late Spring 2019. Ms. Bastin also indicated that the glazing study will be broken into two separate Requests for Proposals (RFP). The first RFP will request sketches, examination of material changes, and preliminary cost estimates. The second RFP will ask for complete mock-ups, manufacturing of parts, and testing.

Task Force Member Carron suggested that the RFP should require that responses preserve the architectural integrity of the original structure, in order that the Michell Park Horticultural Conservatory Domes maintain its eligibility for Historic Tax Credits.

Ms. Bastin stated that she is working with the Office of Corporation Counsel to allow proposers who respond to the first glazing RFP, also be permitted to respond to the second glazing RFP.

6 Status of Staffing, Progress, and Timeline for Phase III of the Future Path and Feasibility Study. (ACTION ITEM)

Task Force Member Carron distributed materials to Task Force members, which are attached to File No. 19-102, Item 1 on this agenda, as "Phase III Feasibility Study Draft RFP Cover Memo" and "Phase III Feasibility Study Draft RFP."

Task Force Member Carron indicated that FM-DAS, has been working in conjunction with the Department of Parks, Recreation, and Culture, and the Office of the County Executive to develop the Phase III Future Path and Feasibility Study Request for Proposals (RFP). Task Force Member Carron summarized the report, and indicated that the RFP will seek to address both capital improvements, and a sustainable, long-term business plan. Member Carron stated that responses to the RFP will require completion and approval by the Task Force by August 5, 2019.

Chairman Lynch recommended the Task Force revise the RFP to narrow the range of potential partnerships to be explored by the contractor. Task Force members agreed to send comments and revisions on the draft RFP to Chairman Lynch by Friday, February 22, 2019, for incorporation into the final RFP.

7 Discussion of Domes Task Force Meetings with Milwaukee Public Museum Task Force and Deliverables. (INFORMATION ONLY)

Task Force Member Smith stated that he anticipates receiving an initial draft of a report from Gallagher and Associates, the contractor engaged to conduct an anlysis of the needs of the Milwaukee Public Museum and the Mitchell Park Conservatory Domes, within the next few days. Member Smith indicated that he believes the full report will be available at the March 12, 2019, meeting of the Committee on Parks, Energy, and Environment, and at the March 14, 2019, meeting of the Committee on Finance and Audit.
