A RESOLUTION/ORDINANCE

WHEREAS, Milwaukee County (the County) established a Capital Improvements Committee (CIC), to review, score, and prioritize annual Capital Project requests via Section 36 of the Milwaukee County Code of General Ordinances (the Code), and since 2014, the CIC has been continuously functioning; and

WHEREAS, the CIC uses an established scoring criteria to evaluate and prioritize annual capital project requests:

1) Safety

- 2) Policy/Plan
- 3) Net Annual Impact on Operating Costs
- 4) Deferred Maintenance
- 5) American Disabilities Act/Building Code
- 6) Non-County Funding
- 7) Continuing Program
- 8) Racial Equity
- 9) Building Mission
- 10)Climate Action

; and

WHEREAS, in 2019, the CIC developed a racial-equity criteria component that has been used as part of the annual Capital Project scoring, evaluation, and prioritization, which began with the 2020 Budget review process; and

WHEREAS, the CIC provides a non-binding, advisory report to the Milwaukee County Board of Supervisors and the County Executive, to assist policy makers with development of the annual Capital Budget; and

WHEREAS, during the 2025 Committee on Finance-Budget hearings, 2025 Adopted Budget Amendment No. 07 directed the Office of Strategy, Budget, and Performance to provide an Ordinance change to Section 36.01 of the Code, to specifically include racial equity as a factor when the CIC determines Capital Project priorities; and
