 - A. Authorization to approve and execute a twenty-five year easement with one (1) ten-year renewals with MCI metro Access Transmission Services for an underground telecommunication system within the Milwaukee River Parkway.
 - B. Revenue will be calculated at five dollars a linear foot. The lineal footage is 3,812, so the first-year fee will be \$19,060. Rate will increase three percent a year.
 - C. The revenue for the easement will help meet revenue targets for this and future budget years.
