  - **A.** The action requests approval to contract with Ezekiel Community Development Corporation (Ezekiel HOPE) to deliver the Post-Release Skills Training Program (PRSTP). The program provides two training cohorts per year offering vocational skills, OSHA-10/CPR certification, tools, PPE, and jobreadiness services for individuals transitioning from the CRC. Adoption of this action expands reentry services and increases participant access to credential-based training.
  - **B.** The Year 1 program cost is \$150,000, based on two \$75,000 cohorts. Costs rise modestly due to inflation and materials increases: Year 2–5 annual costs are \$155,000, \$160,000, \$165,000, and \$170,000.
  - C. Year 1 costs will be supported by the CRC operating budget, with no additional appropriation needed. Future-year costs will be included in CRC budget requests. Total compensation for the initial three-year term shall not exceed \$465,000, unless otherwise authorized in writing by the County. Total compensation for the entire contract term, including up to two optional renewal years if exercised, shall not exceed \$800,000, and existing appropriations are expected to adequately cover the program.
  - **D.** Assumptions include: two cohorts per year; cost increases tied to inflation; steady participation; no new revenue sources; no one-time or capital costs; and adoption of CRC's proposed budgets. Program scope and cost structure are assumed to remain consistent.
